Informations sur les parutions récentes

Arigne Viviane, Christiane Rocq-Migette, eds, *Metalinguistic Discourses*, Cambridge Scholars Publishing, 2015, ISBN 978-1-4438-7258-4, prix : £52.99

This book was born from the desire to conduct an inquiry into the heterogeneity and variety of linguistic theories in order to assess their descriptive and explanatory power. The first part of the volume brings together contributions addressing formal and theoretical issues. It focuses on the specific questions of metalinguistic discourses, representations and formal symbols, and considers the case of representations pertaining to different metalinguistic levels and their possible translation from one level to another. The essays compiled in this section also examine how generative semantics paved the way for current trends in cognitive linguistics, and provide an analysis of the historical and epistemological context of the notion of metafunction found in Systemic Functional Grammar. The contributions gathered in the second part of the book evaluate the results of a certain number of linguistic studies, putting various theories to the test. They specifically discuss the notion of intersective gradience, analyse modality and the question of irony within two different theoretical frameworks, and deal with parenthetical verbs in the light of an utterer-centred approach.

De Bot, Kees, *A History of Applied Linguistics : from 1980 to the present*, London, Routledge, 2015, 154 p., ISBN 978-1-13-882066-1, prix : 37.95 \$

How has Applied Linguistics been defined and how has the field of Applied Linguistics developed over the last 30 years? Who were the leaders that pushed the agenda? What are the core publications in the field? Who are the authors that have been cited most and how is that related to leadership? What were the main themes in research? Why did formal linguistic theories lose so much ground and the interest in more socially oriented approaches grow? What has been the impact of Applied Linguistics on language teaching?

Adopting a theme-based approach, this book answers these questions and more and forms a history of Applied Linguistics from 1980. The structure of this book is largely defined by the topics covered in interviews with 40 leading international figures including Rod Ellis, Diane Larsen-Freeman, Susan Gass, Henry Widdowson, Suresh Canagarajah and Claire Kramsch.

Supplemented with questionnaires from a further 50 key applied linguists, this is essential reading for anyone studying or researching Applied Linguistics and will be of interest to those in the related area of English Language Teaching.

Archibald Henry Sayce (1845–1933) became interested in Middle Eastern languages and scripts while still a teenager. Old Persian and Akkadian cuneiform had recently been deciphered, and popular enthusiasm for these discoveries was running high when Sayce began his academic career at Oxford in 1869. In this two-volume work of 1880, Sayce attempts to give ‘a systematic account of the Science of Language, its nature, its progress and its aims’. As he explains, the methods and theories which underlie the work were set out in his 1874 Principles of Comparative Philology (also reissued in this series). In Volume 1, Sayce outlines the history of theories of language, and the development of a science of language, and considers the causes of language change, phonology, morphology and comparative syntax. Chapter appendices examine topics such as the vocal organs of animals and the various phonetic alphabets then in use.
